A Introduction of Traffic Safety Manager

Weston Stroud is the new Macon-Bibb County Traffic Safety Manager.

B Reviewing current GDOT projects

Weston Stroud presented a presentation to the board outlining GDOT Projects. He also captioned the conversation on the following projects.

1. 0017394 Hybrid roundabout at Mercer University Drive and Anthony Road/Burton Avenue

- Hybrid roundabout at Mercer University Drive and Columbus Road
- **Suggested adjustment**
 - **Vegetated median on Mercer University Drive**
 - **Mid-block crosswalk at Mercer University Drive and Dixon**
 - **Bike lanes to negotiate roundabout in final design from Montpelier /Columbus Road (bike lanes end at Berkner Ave and Columbus Road intersection)**
 - **Currently both sides of Montpelier Ave /Columbus Road have bike lanes that connect downtown/Mercer to the westside of Macon on 1.5 mile stretch along Montpelier Ave /Columbus Road from the intersection on Carling Ave to the intersection Berkner Ave.**

2. 0017395

- Converting the existing signalized intersection at Pio Nono Avenue and Anthony Road into a single-lane roundabout

- **Suggested adjustments**
 - **Additional mid block cross walks before and after the roundabout**
 - **Collaborative out reach with nonprofit and community partners to prep community and property owners during open house and ROW acquisition.**

3. 0018327

- This project proposes to re-stripe and add a road diet, rumble strips and sidewalk installation on the northside of Eisenhower Parkway in Bibb County
- **Suggested adjustments**
 - **Adding protected bike lanes instead of buffered bike lanes because of the rate of speeding on that road.**

4. 0018328

- The proposed four-legged roundabout at the signalized intersection of Eisenhower Parkway at I-75 Southbound Ramps
- **Suggested adjustments**
 - **Adding protected bike lanes instead of buffered bike lanes because of the rate of speeding on that road.**
