The meeting was called to order at 12:07 p.m.

2. Approval of Minutes

A 07-17-2025 Meeting Minutes

On motion of Scott Mitchell, seconded by Christele Parham, and carried unanimously, the Board voted to amend the meeting minutes from July 17, 2025, to include the history of how Rosa Parks Park was named after Rosa Parks. The minutes should reflect the history provided by both former Mayor C. Jack Ellis and Mr. George Muhammad.
