Pastor Bo is third-generation Pentecostal, born into a pastor's home. His father has served as a Pastor for over forty years. Accepting the call to ministry in 1988, he served as State Evangelist of the Church of God of Prophecy until 1991. He then joined the Church of God of Cleveland, Tennessee where he continued his evangelistic ministry over the next three years. During Tenure years as an evangelist, he traveled throughout the South Eastern United States, witnessing the salvation of hundreds. Becoming the Senior Pastor of Harvest Renewal Worship Center in 1995, he was able to grow the church from just a hand full to the largest church in the city. It was during this time that he launched his first successful television ministry, "This Life's For You". In December of 2007 Pastor Bo, heeding the call of God, moved from South Georgia to Macon, Georgia to become Senior Pastor of Real Life Church, one of the fastest growing churches in the middle Georgia area, with over 1,100 members. Since taking over as Senior Pastor he has launched a new television ministry, airing on Our Local CTN, entitled "Living the Real Life".
